The ONE DATA platform developed by ONE LOGIC allows for the creation and implementation – within the space of a few weeks – of AI-based data products that use forecasts to automate and improve decision-making. In the automotive industry, for example, ONE LOGIC has developed a forecasting and recommendation tool that allows dealers to predict the needs of their customers with more accuracy and put together an optimized inventory based on this. After the successfull go-live, the system will soon be used worldwide. ONE LOGIC developed an AI-assisted corporate audit solution for a major German chemical group which allows process deviations to be identified in real time and potential risks to be continuously monitored.


